Subject:- An application under Section 19 of the Right to information act 2005, seeking directions for the compliance of the appellate Order dated 19th May 2011 passed by your good self.

Sir,

With great respect and humility it is submitted as under :-

- 1) That initially I had filed an RTI application dated 3.12.2010 seeking the following information:-
 - a. "Whether the Police Department has sent any communication to various government agencies including Income Tax, Enforcement Directorate and Department of Revenue Intelligence, regarding the threat perception to Mr. Lalit Kumar Modi?
 - b. Inspection of the entire files (s) / documents relating to the communications sent by the Police Department to various Government Department (viz. Income Tax, Enforcement Directorate and Department of Revenue Intelligence) and take copies thereof."
- 2) Though the information officer had rejected my prayer for supply the aforementioned information, however, the learned appellate authority had allowed my appeal.
- 3) That despite such appellate order Prayer (b) aforementioned was never complied with as in terms thereof I was not granted inspection of the file therefore I could not take copies of relevant documents from the file.

- 4) Thereafter I had filed a complaint in the state commission for the compliance of the Appellate order.
- 5) Thereafter I had also filed a detailed application under the RTI Act seeking further information / documents etc. However the information officer again refused to furnish the information vide his order dated 7.3.2011 received on 5.4.2011.
- 6) Aggrieved by the aforesaid order dated 7.3.2011 received on 5.4.2011, I had preferred an Appeal on 11.4.2011 and your good self after hearing the parties, was pleased to pass an order to the effect that in case if I am granted my prayer in terms of Para (b) of my application dated 3.12.2010, (inadvertently referred to in your order dated 19.5.2011 as the application dated 24.2.2011) then my request for information would be satisfied. I reserve my right to file an appeal there against.
- 7) That Your Good self was also pleased to fix the date and time of such inspection as 24.5.2011 at 12 P:M, and in compliance thereof I had duly appeared for inspection along with my friend Mr. Vivek Gore on 24.5.2011, however the concerned officer had informed me that a copy of the appellate order has not reached him. Though the concerned officer was kind enough to allow me the inspection of the file for around 20 minutes which contained documents in Marathi, a language unfortunately despite my best of efforts I am not well acquainted with, however no copies were given to me because of the reason that the appellate order has not reached the concerned officer.
- 8) That thereafter despite my best efforts, I have neither been granted a complete and meaning full inspection nor I am being granted the copies of the documents, therefore I am constrained to make this application for the reason that as I gather from the conversation with the concerned officer that his interpretation of the order dated 19.5.2011 appears to be that I was to be shown the file on 24.5.2011 and I was not to be granted any copies of the concerned documents whereas my difficulty is that the order is categorical that I can inspect and take copies, now for the purpose of inspection I need time to read and understand the documents and then take copies of the relevant documents. In these circumstances I am approaching your good self for a limited indulgence that the concerned officer may kindly be advised as to the true and correct interpretation of your order and he may kindly be directed to grant me a meaningful and effective inspection of the file and grant me the copies of the documents which I desire.


